- (ii) Original SC/ST/OBC Certificate candidate issued by the prescribed authority viz Chief Presidency Magistrate/Presidency Magistrate/District Magistrate/ Collector/Dy. Commissioner/Additional Dy. Commissioner/ 1<sup>st</sup> Class Stipendiary Magistrate/ 1<sup>st</sup> Executive Magistrate and Sub-Divisional Officer in the statutory format (OBC Certificate must be issued during 2018-2019 on prescribed format for job in Central Government Organisation along with Non-Creamy Layer Certificate).
- (iii) The enclosed Proforma of Character and Antecedents Certificate from the Head of the Institution where you have studied last, duly attested by any of the authorities indicated in the Proforma certificate with proper Office Seal.

It may be clearly understood that although effort will be made to absorb you in the regular cadre of this Railway, if there is any vacancy after your successful completion of the period of training but no such guarantee is given therein
- (iii) If at any time during the training period, both at the Training School and in the Division/Unit you do not satisfy your superior authorities that you are making good progress. You may be discharged from the trainee-ship.
- (iv) You are also liable to be discharged after being given 07 days notice or pay in lieu of notice during the period of your training both in the Training School and in the Division, if your conduct is found to be unsatisfactory by the Superior Officer under whom you may be placed for Undergoing training.
- (v) If you are selected for provisional appointment against a working post on completion of your prescribed training you will have to serve the Railway Administration for a minimum period of 05 years.
- (vi) You will not be allowed to withdraw from training except for any reason which are beyond your Control.


