

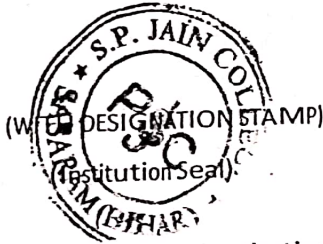

MEMORANDUM

The undersigned hereby offers **Shri Samar Shadab** (Qualifying Category- **OBC**) the post of Security Assistant/Exe in this Bureau in temporary capacity on the basis of Exam 2018, with pay at the first Cell of Level 3 of the Pay Matrix. The appointee will also be entitled to draw the dearness and other allowances at the rate admissible under rules and orders governing the grant of such allowances in force from time to time and subject to the conditions laid down therein.

2. The terms of appointment are as follows:-

(i) He/She will be on probation for a period of two years, which can be extended by the appointing authority. 
