



1. You are hereby offered an appointment as Probationary. ASM /SM in Scale Rs. 5200-20200+2800(GP)/9300-34800+4200(GP) under training period on Rs. 35400/- per month plus Dearness Allowance as admissible under the Rules.
2. The appointment offered to you is purely temporary and your services are liable to be terminated in case you are surplus to requirements and on 14 days notice or pay in lieu thereof also your services are liable to be terminated for any act of indiscipline, misconduct etc. or for poor progress on giving 24 hours written notice.
3. You will be considered for appointment in the permanent post according to your seniority and also completion of two years of probationary period required for same
4. Though you are offered initial appointment of this division and your subsequent promotion will normally be on this division, you remain liable in the exigencies of service to be transferred any where on this Railway. You should therefore state definitely in your acceptance that you will abide by this condition. The appointment is subject to your passing the prescribed medical examination. The medical memo for medical examination will be given to you on reporting to this office.
5. The appointment is made for Tfc Deptt.
